



Commuter Lounge Shuttle Transportation Rules

Service

- The vehicle is to be used solely for the purpose of transporting crashpad members to and from the airport and/or bus stop
 - Family members, spouses, friends, significant others, etc are not permitted to ride in the vehicle without prior authorization by Landlord
- A cellular telephone will be placed in the house and will be used only as a means for transportation contact
 - Designated drivers are responsible for keeping the phone charged while not in use and within audible range
 - Cell phone should be taken with driver when making a trip in case another incoming call comes in while enroute
- Qualified members of the house may volunteer to be a designated driver and will benefit from his/her services as described below*
- In order to cover the operational costs of the service such as vehicle maintenance, gas, and insurance it is necessary to have a small fee



Fees

- One-way ride to and from the Airport = \$2.50/per passenger
- One-way ride to and from the bus stop = \$0.50/per passenger
- Billing: We will invoice passengers at the end of the month along with rent for the following month.

Responsibility

To cover any damages, or non-payment of bills, all participants must submit a \$50 security deposit along with the signed contract, which they will receive back when they discontinue using the service. Landlord provides no insurance for Tenant's personal safety. Tenant agrees to indemnify, defend and hold Landlord harmless and in no way accountable for any liability for personal injury or property damage caused by use of the vehicle. **Any reckless abuse of the service such as accidents, speeding tickets, traffic violations, and harm caused to others, or damage to the vehicle will cause us to immediately discontinue the service.**

***Driver**

- Tenants can volunteer to be a qualified designated driver
 - Must be very comfortable driving a manual transmission sedan
 - Must have a clean driving record
 - Must be familiar with New Jersey traffic, roads, and weather
 - Must provide a copy of a valid State Drivers License
 - Driver must have 0% blood alcohol level when operating the vehicle
- Designated drivers will benefit by being given credits that will go toward his/her own transportation needs (*the credits have no monetary value*)
 - One dollar (\$1) per round trip to the airport or bus stop (Fewer than 2 passengers)
 - Two dollars (\$2) per round trip to the airport or bus stop (3 or more passengers)
- Designated drivers will be responsible for accurately filling out the log sheet, the safe transportation of the passengers and vehicle
 - The driver will be responsible for recording his/her passengers per leg of the trip in the Log Book.
 - The driver will check the vehicle prior to use and record on the log sheet if there are any apparent damages
 - The driver must only travel to or from the bus stop or airport using pre-determined routes
 - The driver must adhere to all state/local laws, and all of the rules

Passenger

- **Vehicle is only authorized for transportation to and from the Bus/Airport**
- Each passenger is responsible to pay his/her fare of \$2.50 to the airport or \$.50 to the bus stop
- All occupants must wear safety belts
- Please travel in groups if possible to minimize trips for the driver
- No smoking in vehicle
- Passengers must verify that they are recorded on the log sheet by the driver and pay for their usage each month.
- If a qualified driver is not available, you will still have the option of taking public transportation.

The foregoing constitutes the entire Agreement between the parties and may be modified only in writing.

Wherefore, we the undersigned, do hereby execute and agree to this agreement, and the rules specified within.
